# Practical and Logistical Information

- Meetings will be held primarily in person to facilitate full negotiations. Speaking in plenary sessions and contact groups generally limited to those present in the meeting venue.

  - limit on number of representatives on site at any one time 6/Party and 2/observer organization
  - provision will be made to allow delegations from Parties and observers to follow the sessions of the meetings, both plenary and contact groups, virtually (viewer mode only).
- In the event that it is not possible for a Party to be represented physically in Geneva, full interactive virtual participation will be enabled following a special request to the Secretariat.
- Funding available to support two representatives per eligible Party (developing countries, in particular LDCs and SIDs, and countries with economies in transition), subject to availability of funds.

# Key Considerations: Where are we?

#### We are getting back to pre-COVID modus operandi



#### Discussions are at different stages for each agenda item.

- Some discussions may begin or resume a first reading, while other discussions may resume in a contact group. Some agenda items are at a more advanced stage and ready to review a CRP.
- Delegates are urged to review the supplementary annotations to the agendas for each meeting as well as the joint Scenario Note to learn 'where we are' on specific agenda items.

## Key Considerations: Where are we?

#### **SBSTTA and SBI**

Delegates will resume their work where they stopped at Part I of their meetings. They will basically 'pick up where they left off'.

#### WG2020

While Draft One remains the official starting point for negotiation, delegates are encouraged to keep in mind the composite text and the compiled list of all proposals contained in the report of WG2020-3.1 and to make best use of the Co-Chairs' Reflection text.

# Facilitating Discussions and Resolving Issues

- Meeting time will be very limited flexibility and cooperation will be key for making maximum use of the available time.
- We should avoid duplication of discussion across SBs and CGs
- The Chairs and Co-Chairs may convene informal groups, such as Friends of the Chair, to help make progress. The modalities for such meetings will be clearly communicated to participants to ensure transparency.
- Informal consultations among Parties ahead of formal consideration in plenary may help resolve brackets.
- Informal consultations outside of formal meetings can also facilitate progress – huddles can be helpful.
- **Reminder** After extensive discussions in contact groups or informal consultations, discussions in plenary are usually kept brief.

### Observers

- Similar to pre-COVID practice
- Recognizing regional groups, Parties, Non-Parties, major stakeholder groups and observers
- Using 6 min-3 min rules
- Chairs and Co-Chairs will recognize observers as much as schedule allows
- Importance of engaging in contact groups and informally

## **Overall Coordination**

- In advance
  - A lot of detailed planning was done ahead of the meeting
- In Geneva
  - Regular Chairs, Co-chairs and Secretariat meeting to discuss logistical and coordination issues
  - Regular Joint Bureaux meeting
    - E.g. to review and adapt schedule as needed

# WG2020-3 Expectation for Resumed Meeting

- Contact groups from WG2020-3.1 will be carried over to WG2020-3.2
  - Same mandate
  - as much as possible same Co-leads (some changes were unavoidable)
- Focus on negotiations (avoid general statements or repeat comments made in WG2020-3.1)
- First Draft remains basis for negotiations
  - CG Co-leads reports (list of Party/stakeholder proposals and composite texts)
  - Co-Chairs Reflections provide further guidance and can be useful
- Ideal outcome: Negotiated text with as few brackets as possible for consideration by COP15
- DSI: Make progress on solutions for the long-term
- A guidance document with further details will be posted ahead of the meeting.
  - More details on CG agenda
  - Relationship between CGs

## WG2020 Contact Groups

- WG2020 contact groups will use common approach as much as possible:
  - Co-leads determine time allocation and can prioritize work
  - Short introduction by WG2020 Co-chairs. This can include:
    - Summarize previous versions or iterations of documents since 2018
    - Elements of the Co-chairs Reflections Document
  - A non-paper can be introduced after first session
  - Interventions
    - Parties are encouraged to refrain from making general statements
    - Keep interventions short, focused on text, and work towards compromise
  - Glossary
    - It may be useful for Contact Groups to reflect on relevant definitions
