



# 25TH ANNIVERSARY OF THE INTERNATIONAL POLLINATORS INITIATIVE (IPI 25)



**CAMPAIGN REPORT** 

#### **IPI 25 CAMPAIGN**

Pollination is a vital ecosystem service that maintains biodiversity and life on Earth. The functioning and health of agricultural and natural ecosystems, as well as people's well-being, livelihoods and access to food depend on pollinators. Yet, habitat loss, misuse of pesticides, parasites and pathogens, invasive alien species, climate change, among others, are putting their survival, and ours, at risk.

In response to the urgent need to halt and reverse pollinator diversity loss, the International Initiative for the Conservation and Sustainable Use of Pollinators (IPI) was established at COP 5, which took place in May 2000 in Nairobi, by decision V/5. Subsequently, the updated Plan of Action 2018-2030 for the IPI, prepared jointly by the Food and Agriculture Organization of the United Nations (FAO) and the Secretariat of the Convention on Biological Diversity (CBD), was adopted by decision 14/6. The Plan of Action is aligned with the Kunming-Montreal Global Biodiversity Framework, the world's master plan to halt and reverse biodiversity loss.

This year marks the 25th anniversary of the IPI. To celebrate, the CBD Secretariat launched a campaign to highlight the milestones collectively achieved and promote global action to shape a brighter future for pollinators. The present report covers the first two weeks of the campaign, from 16 to 28 October 2025.

#### **IPI LOGO**

25 years of coordinated action worldwide to safeguard pollinators deserves recognition. To commemorate this milestone, the CBD Secretariat created a logo that captures the essence of the IPI. This new visual identity is designed to raise the profile of the initiative.





# 25TH ANNIVERSARY OF THE IPI @ SBSTTA-27

Over the past 25 years, the IPI has catalyzed important progress. Many Parties to the CBD have developed regional, national and subnational initiatives, strategies, action plans and programmes to safeguard pollinators. In addition, indigenous peoples and local communities, NGOs, international organizations, farmers, beekeepers, the private sector as well as civil society have undertaken various actions to protect pollinators worldwide.

To celebrate the 25th anniversary of the IPI, the CBD Secretariat, the Government of Mexico through the Secretaria del Medio Ambiente y Recursos Naturales (SEMARNAT) and the Comisión Nacional para el Conocimiento y Uso de la Biodiversidad (CONABIO), and FAO organized an event to reflect on the achievements and discuss the next chapter towards the conservation and sustainable use of pollinators. The event took place on 20 October 2025 in Panama City, in Panama City, during the twenty-seventh meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA-27).



# 27th meeting of the Subsidiary Body on Scientific, Technical and Technological Advice



An open discussion on "25 Years of the International Pollinators Initiative: Charting the Path Ahead" followed, with all participants encouraged to take the floor. On behalf of Colombia, the Ambassador Pedro León Cortés Ruíz welcomed the anniversary, noting that Colombia is developing its National Strategy for the Conservation of Pollinators, while strengthening research, monitoring and restoration of critical habitats for native bees, bats, butterflies and hummingbirds. He concluded with a message of hope, cooperation and collective action to protect pollinators, and ultimately life on Earth and the common well-being. The event closed with remarks from Michelle Gaelle Bidima, Member of the Global Youth Biodiversity Network.
